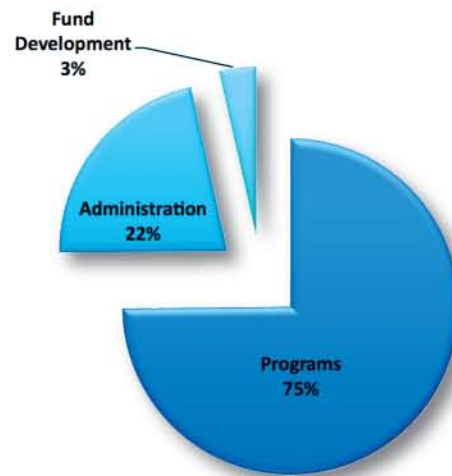

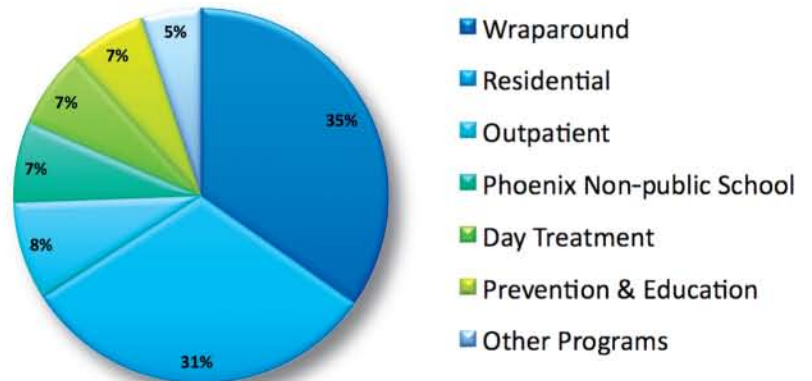

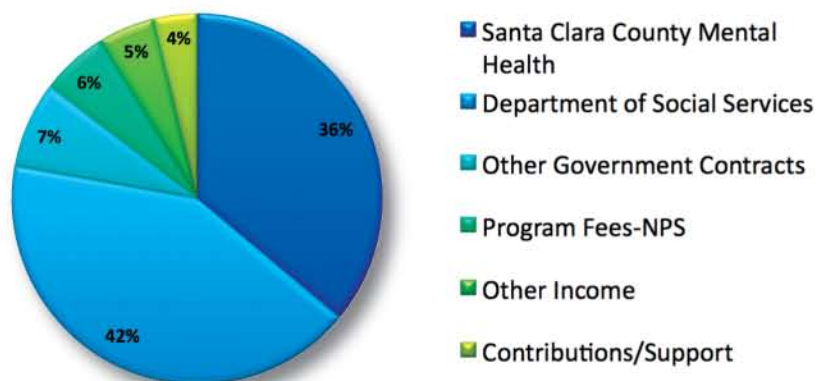
Audited Expenses



Program Expenses

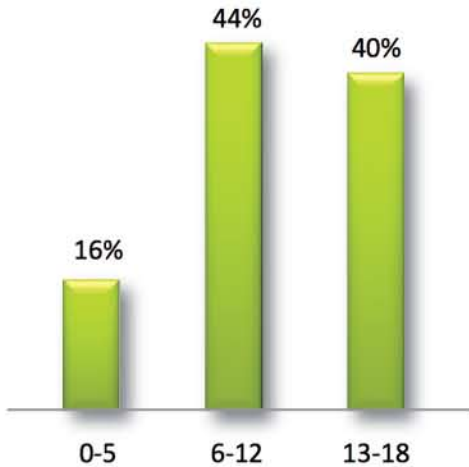


Audited Revenue

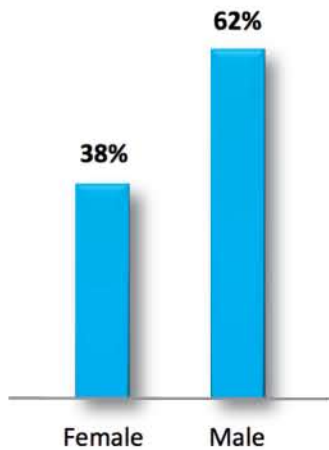


Population Served

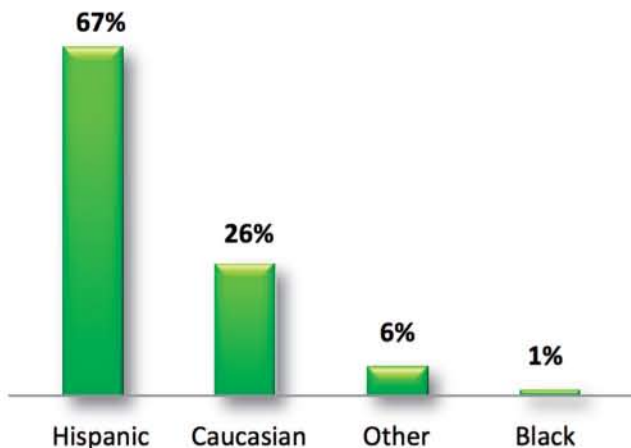

Kira's Story

Kira came to Rebekah Children's Services in the spring of 2009 just before her 17th birthday, with no intention of staying. She had run away from every other placement, the longest had lasted about three days. Her mother loved her; however after Kira's last hospitalization for mental health needs made the heart wrenching decision that she couldn't take her home and keep her safe.

Something at Rebekah's was different for Kira, she found herself still here after a week and then a month. She felt connected to the staff, that they cared about and respected her. Then she had made it through the summer and was starting her senior year at Phoenix Non-public School. In January 2010, she transitioned to local public high school where she was a straight-A student, participated in choir, and attended her prom.

Kira became a proud high school graduate in June of 2010 and returned home to live with her mom. With the help of Rebekah Children's Services staff, Kira enrolled in a local community college, obtained scholarships and grants to cover tuition expenses, and is now in her 3rd semester. Her beaming smile as she talks about future plans for nursing school says it all.
